PRESIDENT'S REPORT: President Meyerhoeffer reported the following:



2. Dennis Johnson was on campus last week as a consultant on marketing. He suggested that we had many brochures that were published on campus, but suggested that they have a common theme. He also suggested that we look at an advertising budget.
3. An AIDS policy for the college is being considered.
4. Student enrollment is up 11 percent on FTE. The head count is not up that much which indicates that students are taking a larger class load.
5. The presentation was made to the State Board of Education on the 1989 budget request. The State Board approved a 15.2 percent increase in the state academic appropriation.
