- **Personally responsible** - I understand that I owe the full amount of the loan and am personally responsible for making the above payments.
- **Financial Aid** - In the event I receive Financial Aid or other financial assistance, I understand that the College may use those funds to reduce or pay off the balance of my loan before I receive any of the money from such aid. **If I "do not" receive Financial Aid I understand that I am personally responsible for making the payments due on my account according to the above schedule.**
- **Processing Fee** - I understand that I must pay a non-refundable \$50 processing fee in advance before the College will grant me any extension of time for paying my fees.
- **Dropped for non-payment** - I understand that if I fail to make the scheduled payment by the above due date I will be dropped without notice and my account balance along with any reinstatement or additional fees will become immediately due. I also understand that if the College does drop me for non-payment I am still responsible for paying any balance due on my account.
- **Financial Holds** - I understand that the College will not issue transcripts and reserves the right to withhold my grades, diplomas, subsequent registration, housing assignments, payroll checks, etc., if my account has an outstanding balance.
- **Failure to Pay** - I understand that if I fail to make an arranged payment, the College can require immediate payment of the entire balance. I understand that the College may refer the account to an outside collection agency. I understand that if the College does place my account in the hands of a collection agency an additional 33% of the outstanding balance will be added to my account.
- **THE LAST DAY FOR 100% REFUND OR TO WITHDRAW AND OWE NOTHING FOR FALL TERM IS 9-11-09. IF I WITHDRAW OR AM DROPPED BY FACULTY OR STAFF AFTER THAT DATE I WILL STILL OWE IN FULL.**
